- 8. Promotion commences on 1/12/2024 at 9am AEST. Entries close at 11.59pm AEST on 12/12/2024 (Promotional Period).
- Entries must be received during the Promotional period. No responsibility accepted for late, lost or misdirected entries. Incomplete or indecipherable entries will be deemed invalid.
- 10. The value of the total prize pool is \$2,500.
- 11. There will be one (1) prize and one (1) winner each day for twelve (12) days. A total amount of 12 (twelve) prizes and twelve (12) winners with each winner receiving a set prize (the prize) per day.
